## Competitive Selection Process for the Procurement of Ancillary Services to the Grid

## **BID BULLETIN NO. 2022-01**

This is to provide the change in schedule of activities in the conduct of Competitive Selection Process (CSP) for the procurement of Ancillary Services (AS).

The deadline of submission of questions on the bid documents provided to the Eligible Bidders was on May 23, 2022, which is the same date of the Pre-bid Conference with the Secretariat receiving significant number of queries from the Eligible Bidders. After responding to some queries, the TPBAC suspended the Pre-bid Conference due to lack of material time and announced that a second Pre-bid Conference will be scheduled at a later date to address the rest of the queries from Eligible Bidders.

In response to the queries raised by the Eligible Bidders, and as a result of the TPBAC deliberation on the proposed amendments to the bid documents, a corresponding change in the schedule of activities has been approved as shown below:
